




## What is the Summer Food Service Program (SFSP)?

- The Summer Food Service Program (SFSP) provides free meals and snacks to children <18 at sites in low-income communities
- Most meal sites provide educational, enrichment or recreational activities that keep children learning, active and safe when school is not in session.
- These programs contribute to children's healthy growth and development by providing them with nutritious meals and snacks over the summer months, a time when children can be more at risk for hunger and weight gain.

#### **Research Question**

# What was the impact of the 2020 USDA waivers and COVID-19 on summer meal program operations and on the experiences of Maryland SFSP sponsors in summer 2020?



# Methods

#### Data Collection


#### Data analysis - Quantitative

- Univariate and bivariate statistics calculated for all sponsor characteristics
- Perceived Impact of Waivers items were assessed by asking agreement with statements. Agreement was measure on a 5-point Likert Scale with 1 indicating Strongly Disagree and 5 indicating Strongly agree.
- Perceived impact of COVID-19 on sponsor operations was assessed using a similar 5-point Likert scale.




# Results

## Maryland 2020 Summer Food Service Program Meal Sponsor Respondent characteristics (n=26)




## Maryland 2020 Summer Food Service Program Meal Sponsor Respondent Awareness of Waivers (n=26)

Perceived Positive Impact of Waivers on feeding children during COVID-19 related school closures




#### Maryland 2020 Summer Food Service Program Meal Sponsor Respondent Awareness of Waivers (n=26)

Respondents were overwhelmingly aware of each of the waivers

- Highest awareness (92%): Waivers 1 and 7, allows for service of meals outside of standard mealtimes and area eligibility waivers which extends eligibility for free meals in communities
- Lowest awareness (69%): Waiver 4, allows meal pattern flexibility
- ▶ 81% (n=21) were aware of five or more waivers.
- All respondents reported that they were familiar with at least one of the waivers.
- Respondents overwhelmingly perceived a positive impact of 2020 waivers on feeding children during COVID-19 related school closures

#### Conclusions

- > 2020 USDA waivers impacted the operations of the SFSP 2020 MD Sponsors.
- The majority of Maryland SFSP sponsors overwhelmingly perceived a positive impact of 2020 waivers on feeding children during COVID-19 related school closures.
- Half of the 2020 SFSP sponsors reported serious concerns about:
  - Safety of their staff
  - Potential that students would go hungry during the summer
  - Providing meals that would not be guaranteed reimbursement under SFSP

#### Implications

- Federal policy changes can have large impacts on local agencies especially during a national crisis.
- Statewide waivers on behalf of their SFSP sponsors are important in the provision of meals to low-income children during out-of-school time necessitated by a crisis.
